1. 3. Service standards fit: public institutions and the managers of their organizations, and others staff, public services to the specified standards ve to the processes suitable in a way execution, those who benefit from the service work ve Clarification regarding the procedures.

4. Objective ve commitment to the mission: You officials of the institutions they work for or the organization's purpose and its missions suitable behavior, country interests, social welfare ve services of institutions ideals acting in accordance with that.

5. Honesty ve impartiality: Public officials, all action ve in transactions legality, justice, equality, and fairness principles in line with their duties in its place while bringing the language, from philosophical belief, philosophical belief political thought, race, gender not discriminating for reasons such as right basis or contrary to freedoms or restrictive treatment ve equal opportunity inhibitory behavior and not engaging in practices.

6. Respect and trust: You must respect the administration and trust it in a way that will provide the behaving and the reputation and trust required by his position, worthy of the behaviors to be shown, of the people. You undermine trust in the service, create suspicion, and avoid behaviors that harm this principle of justice.

7. Politeness and respect: You , tops, colleagues, subordinates, and other employees must treat those using the service kindly and respectfully, and as required, showing it is outside the scope of their authority to the unit or to the authoritydirection,

8. To the competent authorities notification: Ethics principles of conduct in incompatible or illegal work and actions must be reported to the competent authorities if their presence is requested or while services are being performed, in this kind of action or the situation when the transaction is noticed or observed, through official reporting to the authorities.

9. From conflict of interest avoidance: You officials must remain neutral to perform objectively, without influencing others. It seems to be affecting them visibly, to their relatives

and friends, throwing away to the person or organization with whom it has a relationship, provided they receive various benefits in financial matters related to them or others' obligations, and so on. You must be careful about personal interests, take the necessary precautions to avoid conflict.

10. Duty and interests of powers: You officials must ensure that their powers are not used for the purpose of not providing any benefit in one's favor, in mediation absence, relative spouse, or enough fellow townsmen favoritism, political favoritism, or any other. Therefore, discrimination or favoritism is not allowed.

11. Giftalma and benefit providing prohibition: You officer's impartiality, performance, his decision, or to do his job, influencing or influencing potential economic value, which throw away not, directly or indirectly, her various furniture and interest acceptance not to, well, gift not to . You to the officer: the gift not to be given and duty because of no benefit gained.
